Since 2010, we have delivered 2,997,777 branded bottles of water with words of inspiration and encouragement inscribed on them, such as Hope, Love, Peace and Dream, throughout Texas, Louisiana, Oklahoma and Arkansas. All bottles are rPet bottles that are 100% recyclable.

Face of the American Homeless (Image Campaign): The Face of the American Homeless program has been established to bring a face to who the American homeless are. I Am Waters discovered that a highly productive and meaningful way to engage with the homeless community and create a dialogue was to organize a photoshoot at the various shelters. With the help of a professional photographer, we captured the images of dozens of homeless and used these images as a way to talk with them about their current situation. The aim is to bolster the image they hold of themselves, while providing them with a valuable keepsake.
